TRAILER USE AND CHECKOUT PROCEDURES

- ASTs have priority for use of trailers and total control of all trailer usage
 - Selected Bumper pull livestock trailers may be used by parents or family members who assist the AST in transporting livestock.
- Trailers are used to haul only projects designated to show under Aubrey FFA
- Trailer alterations are NOT permitted.
- Individuals must
- Submit a copy of driver's license to Ag Teachers
- Submit a copy of current insurance.
- Complete Trailer Request Google Form
- Denton County Show, validation, state, and national shows will take precedence over all other shows.
- Trailers will be blocked off for all validation periods and will not be available for checkout until the teacher has released the trailer(s).
- Trailer privileges may also be revoked by Aubrey ISD administration and/or AST at their discretion.
- Any expenses due to accidents or damage will be paid for by the person who checked out the trailer.
- The agriculture gooseneck trailers will only be used by ASTs.
- Trailer requests must be submitted on google classroom 48 hours prior to usage.
 Trailers will be assigned once a completed form and approval is given.
- After the use of the trailer, the student/parent is responsible for completing the post-trip inspection, cleaning and washing out of the trailer. Cleanliness of the trailer will be determined by the AST's
- The trailer must be returned to the same location of pick up. Unless told otherwise.
- Out-of-state travel will be determined on a case-by-case basis
